

# Are Vaccine Ingredients Biblical?

**Why it matters:** The answer to this question has physical and spiritual implications.



# **Part 1 – Vaccine Ingredients:**

Question: Do vaccine ingredients contain human or animal cellular material and/or known toxins?

Answer: Yes. <sup>1, 2, 3</sup> Just as food labels contain ingredient lists, vaccines and other injections also have ingredient inserts containing an ingredient list, but most never ask to see it, including medical doctors. The following are just eleven examples of vaccines manufactured using "human-diploid fibroblast cell cultures", which are cells from aborted human fetuses listed on the Centers for Disease Control (CDC) website, and are often referred to as WI-38, MRC-5, and the newest Walvax-2.<sup>4, 5, 6, 7</sup> Adenovirus, DTaP-IPV/Hib (Pentacel), DTaP-IPV (Quadracel), Hep A (Havrix), Hep A (Vaqta), Hep A/Hep B (Twinrix), MMR (MMR-II), MMRV (ProQuad), Rabies (Imovax), Varicella (Varivax), Zoster (Shingles – Zostavax).<sup>8</sup> Does this make you think of the 1973 movie thriller, Soylent Green? Vaccines contain adjuvants, preservatives, stabilizers, and emulsifiers (including aluminum and mercury) as well as parts from chickens, <sup>9</sup> cows/bovine, <sup>10</sup> pigs, <sup>11</sup> monkeys, <sup>12</sup> insects, <sup>13, 14</sup> dogs, <sup>15</sup> and many more. <sup>16, 17</sup> Vaccine derived illnesses, such as vaccine-derived poliovirus, are also admitted by the World Health Organization (WHO) on their website. <sup>18</sup> Other unintended events occur, such as millions being inoculated with pig virus DNA, <sup>19</sup> as well as cancer-causing viruses per the Food and Drug Administration (FDA). <sup>20, 21</sup> At the time of this writing, Covid-19 vaccinations are set to use radically new and more dangerous mRNA genetic engineering methods never approved before on people, with unknown consequences undiscoverable for decades, <sup>22</sup> as 100K+ doctors warn against it. <sup>23</sup>

# **Part 2 – Polluting God's Holy Temple:**

Question: Are there any biblical examples of God forbidding his people from polluting their bodies?

Answer: Yes, both in the Old Testament<sup>24</sup> and the New Testament.<sup>25</sup> (See references for additional Bible verses)
The consumption of blood is first condemned in the Old Testament, "But flesh with the life thereof, which is the blood thereof, shall ye not eat." Genesis 9:4 (KJV), and is reaffirmed, even to Gentiles, in the New Testament, "But that we write unto them, that they abstain from pollutions of idols, and from fornication, and from things strangled, and from blood." Acts 15:20 (KJV). There are more verses, but these should be sufficient to convey that cell-containing injections puncturing the skin can be at least as severe as consuming blood cells, since it bypasses the body's natural defenses created by God, and followers of God are considered his holy temple.<sup>26</sup>

## Part 3 – Survival vs. Obedience, Faith, and Love:

**Question:** Are there any biblical examples where God preferred that his people disobey him to have a longer, happier, or easier life?

**Answer:** No, the Old Testament and the New Testament are full of examples of God's people suffering or dying to follow God's commands and being obedient out of love. <sup>27, 28</sup> This includes, but is not limited to, Old Testament prophets being killed by Jezebel (1 Kings 18:4), and New Testament followers of Christ, like James, being killed (Acts 12:1-4). There are past, present, and even future examples given in the Bible (Revelation 14:9-11, 20:4). Following God does not guarantee an easy or long life, and often means being shunned or dying (Luke 17:33).

#### **Having Faith Means Trusting God:**

Fear, faith, and love of God should drive a person to obey God. It is forsaking faith in man's ways for God's ways, forsaking our ways for God's ways, and forsaking manmade traditions for God's traditions as revealed in the Bible.

"Let us hear the conclusion of the whole matter: Fear God, and keep his commandments: for this is the whole duty of man." – Ecclesiastes 12:13 (KJV)

#### **New Testament**
