



Soul Ownership: How to Break Soul-Selling Contracts with Biblical Insight

This article argues that such contracts are fundamentally invalid, based on biblical truths and legal principles. Souls belong solely to God—not to individuals or any created beings. Section 1: God's Exclusive Ownership of Souls

The Bible clearly states that God owns every soul. [Ezekiel 18:4](#) declares, “Behold, all souls are mine; as the soul of the father, so also the soul of the son is mine.” This is reinforced in [1 Corinthians 6:19-20](#): “What? know ye not that your body is the temple of the Holy Ghost which is in you, which ye have of God, and ye are not your own? If earthly authority can void promises, God's supreme ownership far more readily invalidates attempts to sell a soul he owns. Humans lack authority to transfer what is not theirs. God's claim is absolute, rendering soul-selling contracts null from the outset.

Section 2: The Legal Invalidity of Soul-Selling Contracts

Beyond spiritual grounds, these contracts fail legally. Enforceable agreements require the seller to own the asset. Selling unowned items, like rented property or stolen goods, makes the deal void *ab initio* (from the beginning). Since God owns souls ([Ezekiel 18:4](#); [1 Corinthians 6:19](#)), individuals cannot transfer them to fallen angels or others.

God, as ultimate Father ([Matthew 6:9](#)), holds greater jurisdiction. This aligns with ancient Roman law: Slaves could not sell themselves without their master's consent, per the [Digest of Justinian \(533 AD\), Book 41, Title 1](#). Under God's unyielding ownership, never ceded in Scripture, no sale occurs without His approval, which the Bible does not grant.

Such contracts also lack lawful purpose, as agreements for immoral or impossible acts (like soul sales) are unenforceable. Thus, they are spiritually and legally void.

Section 3: Free Will, Vows, and Oaths in Biblical Context

Free will allows choices, as in [Deuteronomy 30:19](#): “I call heaven and earth to record this day against you, that I have set before you life and death, blessing and cursing: therefore choose life...” However, it governs behavior and allegiance, not soul ownership.

The Bible regulates vows within God's framework. [Numbers 30:2](#) states, *"If a man vow a vow unto the LORD...he shall not break his word,"* but [Matthew 5:33-37](#) and [James 5:12](#) warn against oaths: *"But I say unto you, Swear not at all; neither by heaven; for it is God's throne: Nor by the earth; for it is his footstool: neither by Jerusalem; for it is the city of the great King. Neither shalt thou swear by thy head, because thou canst not make one hair white or black. But let your communication be, Yea, yea; Nay, nay: for whatsoever is more than these cometh of evil."* [Deuteronomy 23:21-23](#) and [Ecclesiastes 5:4-5](#) stress fulfilling vows to God, but Scripture nowhere endorses irrevocable pacts with evil entities.

Even willing soul sales are overruled by God's claim ([Ezekiel 18:4](#)). Free will permits alignment with good or evil but not property rights over God's possessions. Vowing a soul to a fallen angel is like pledging another's inheritance; it is invalid and unenforceable.



Section 4: The Heavenly Court and the Power of Redemption

In a heavenly courtroom, a fallen angel's contract would be voided by God, the ultimate Judge. All creation submits to Him ([Nehemiah 9:6](#); [Colossians 1:16](#): *"For by him were all things created, that are in heaven, and that are in earth, visible and invisible, whether they be thrones, or dominions, or principalities, or powers: all things were created by him, and for him"*). Fallen angels, once perfect but now corrupt ([Ezekiel 28:13-15](#)), lack authority to challenge God ([Psalm 148:2-5](#); [Romans 14:8](#)).

The prodigal son parable ([Luke 15:11-32](#)) shows a wayward child reclaimed through repentance. God's mercy restores the lost. Christ's redemption ensures victory: [John 3:16](#) offers eternal life to believers, and [Romans 10:9](#) promises salvation via confession and faith. No demonic claim withstands Jesus' blood, which *"hath delivered us from the power of darkness"* ([Colossians 1:13](#)).



Section 5: Steps to Break the Perception of the Contract

Though invalid, the perceived hold of the contract can linger like a shadow, but the Bible provides steps through Christ's authority to affirm its invalidity and bring peace:

1. **Believe in Christ's Sacrifice:** Trust Jesus' death and resurrection, which atone for sins and void rival claims. [Romans 5:8](#) states, *"But God commendeth his love toward us, in that, while we were yet sinners, Christ died for us."* [Colossians 1:13-14](#) adds: *"Who hath delivered us from the power of darkness, and hath translated us into the kingdom of his dear Son: In whom we have redemption through his blood, even the forgiveness of sins."*
2. **Repent Fully:** Reject the contract, sin, and demonic influence. [Acts 3:19](#) urges, *"Repent ye therefore, and be converted, that your sins may be blotted out,"* while [Luke 13:3](#) warns, *"I tell you, Nay: but, except ye repent, ye shall all likewise perish."*
3. **Be Baptized:** Symbolize separation from the old life in Christ's name. [Acts 2:38](#) commands, *"Then Peter said unto them, Repent, and be baptized every one of you in the name of Jesus Christ for the remission of sins,"* and [Romans 6:4](#) explains, *"Therefore we are buried with him by baptism into death: that like as Christ was raised up from the dead by the glory of the Father, even so we also should walk in newness of life."*
4. **Live Out Christ's Teachings:** Commit to obedience ([Ecclesiastes 12:13](#): *"Let us hear the conclusion of the whole matter: Fear God, and keep his commandments: for this is the whole duty of man."*; [John 14:15](#): *"If ye love me, keep my commandments."*; [Matthew 16:24](#): *"Then said Jesus unto his disciples, If any man will come after me, let him deny himself, and take up his cross, and follow me."*). This reinforces freedom and God's ownership.



Conclusion: Understand Your Soul's True Owner

Soul-selling contracts are illusions, biblically void due to God's ownership ([Psalm 24:1](#); [Ezekiel 18:4](#); [Romans 14:8](#); [1 Corinthians 6:19](#)), and legally unenforceable, as one cannot sell unowned property (echoing Roman law in the [Digest of Justinian, Book 41, Title 1](#)). In the heavenly court, God's mercy prevails through Christ's redemption. By believing, repenting, baptizing, and following Jesus ([John 3:16](#); [Acts 2:38](#); [Romans 6:4](#)), you shatter every illusion of bondage.
